Page | 1 This Privacy Policy together with our and Terms and Conditions sets out how OHSMED Limited ("we", "our", "us") will use any personal information we collect from you, or you provide to us during your use of this website.

**Personal Details** 

For the Privacy Act 1993, your personal information ("also referred to as "data") is controlled by OHSMED Limited, a Company registered in New Zealand under Company Number 8196820, NZBN9429049414691. We may from time to time use data processors ("Data Processors"), who are not employees, agents or otherwise connected with us, with whom we have an agreement to process your personal information.

We respect the privacy of every individual who visits the website. In addition to our statutory obligations, our policy on the collection and use of personal information is outlined below.

We may collect and use personal information in order to:

- Administer or otherwise carry out our obligations in relation to any agreement that you may have with us;
- Anticipate and resolve problems with the service we provide to users of the website;
- Carry out market research and the tracking of sales;
- Create and inform you of products and services provided either by us or by carefully selected third parties that you may be interested in, where you have consented to be contacted for such purposes and allow Data Processors to do the same – see Emails and Newsletters below for more information about this.

In order to carry out the above, we may need to collect and process personal information about you (including but not limited to: your name, address, telephone number, email address, details of your visits to the website and any transactional information). We may ask you for this information on the website or at any subsequent point. Your personal information that we collect may be provided to Data Processors for analysis so that we may tailor the goods, services, and marketing materials we, and other third parties, offer to you (where you have consented to receive the same).

To take advantage of some of our services, you may need to supply us with the personal details of a third party (for example, their name and address if you wish to send them something). We will not use this information for anything other than providing the service for which the information was supplied.

We will not disclose any personally identifiable information without your permission unless:

• We are legally entitled to do so;

- We, or substantially all of our assets, are acquired by a third party, in which case personal data held by us relating to or generated by our customers will be part of the transferred assets;
- To enforce or apply our terms and conditions and other agreements; or to protect our rights, property, safety, customers, or others.

By using our services and providing us with your personal information, you acknowledge and consent (subject to your rights set out below) to the disclosure of your personal information as set out herein.

We may automatically collect non-personal information about you, such as the type of browsers you use or the website from which you linked to us. #### Cookies

When you visit our website we send cookies to your computer, or similar device, which are useful for your browsing experience.

We use cookies for marketing purposes too, such as tracking user trends, click throughs (which we may share with branded partners), media performance and search optimisation.

As cookies are useful we do not recommend you disable them but if you want to you can set your browser to notify you when you receive a cookie, which allows you to choose whether or not to accept it.
